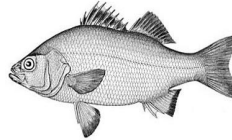


BOULEVARD PARK'S 3rd ANNUAL

**Saturday – June 20, 2009
OPEN TO THE PUBLIC**

1. Entry fee of \$50.00 per boat. Five (5) persons per boat maximum
2. A minimum of ten (10) participating boats is required to be official
3. All fish must be caught off hook & line and in accordance with the State Fisheries laws.
4. A maximum of one (1) fishing rod/line and two (2) hooks per person. Rod must be attended at all times when bait is in the water.
5. Anchoring is **NOT** permitted.
6. All official communications will be on VHF Channel 72
7. No lines will be allowed in the water before 6 a.m.
8. All boats shall operate in a safe and courteous manner when nearing a fishing area. Please go slow and respect your fellow fisherman.
9. Weigh-in is from 3:00 to 4:30 p.m. back at the Boulevard Park Clubhouse.
10. Each boat shall weigh a maximum of five (5) white perch for a total weight.
11. All fish are subject to an internal & external examination & Troy Meter Test.
12. All prizes will be awarded at the weigh-in. Food to follow.
13. Tournament will take place rain or shine.
14. A team name displayed on the boat or a t-shirt is encouraged as this is a tournament that is great for kids and adults of all ages.
15. The ramp will be opened at 5:30 a.m. just for this tournament to outsiders if you are in the tournament. Please advise if you are an outsider boater and will be using our boat ramp.
